Melting of tundra far more rapidly than expected, releasing vast stores of Methane, may create a feedback loop, melting tundra at increasing rates, speeding global warming. We ask that full Civil Rights protections be extended to all who have had their basic freedoms infringed by our complete failure to use the forefront of science and human knowledge, all Eleven Elements of the New Scientific Method, and in ignoring prevention in the fields of health, healing, education, rape, violence, crime, drugs, agriculture, safety, accidents, and war. Major classes of Civil Rights violations have been little noticed. We have allowed the American Medical Association's Pogrom of Alternative Healers to blind us to the massive research in the many Alternative Healing elements that make up Holistic Health. This ongoing "Witch Burning" conspiracy started in 1838, and increased when the AMA started in 1849. The AMA's purpose was to enable the MD Allopathic Medicine System of pills and surgery to get all of the health business. MD's paid Congress under the table for 82 years to be given complete charge of our health care systems, and to outlaw all competitive systems. This continues now with five types of payoffs. Results--a medical system

that is completely blind to biological and herbal medicine. biological nutrition, the role of the mind in health and healing, exercise, yoga breath, and that Energy Healing Is Spiritual Healing, Is Applied Physics that works with the physics of the complex MultiDimensional Holographic Mind Body Energy Field Spirit System that is completely integrated, an indivisible subsystem of our MultiDimensional Holographic Universe.
