ONGOING VIOLATIONS OF LAW and ETHICS IN USA

The failures of SD County HHS, County Hospital Association, UCSD Chancellor, UCSD Medical School Director, Scripps, Childrens Hospital, UC & CSU boards, SDSU Pres, school superintendents, and many other medical, education, media, and political systems we and others have given Holistic Health and safety error reduction training info to would seem to be actionable as a major factor in children and adults suffering and dying unnecessarily because of a lack of education, training, and an ongoing war against scientific Holistic Health care and safety. The Applied Physics of Energy Healing enables identifying the actual basic problems. Healers could even healed her immediately, or after they found the tube had been inserted wrong, or even when serious trouble was finally noticed. This has been proven. Physics applies to people. Cultural Blind Spot research is extensive. Cultural Psychology, history, and Sociology studies of humans discounting new to them info that conflicts with their mind set for many generations will be helpful. Cultural Psych proved that less then 5% of people can even consider new info that conflicts with their mind set. They call this the Vested Interest Syndrome. Schools need stress removal.

The safety training would have prevented wrong insertion. The safety error reduction training has been in professional literature since 1938, every paper in the US in July 1987 when an AP story on the 32nd university study reported that there were 98% less accidents in the study group doing Tai Chi and meditation. Other studies found 99.7% less accidents in study groups doing Aikido and meditation. Many studies find 96% to 99% less errors with this training. This has been mentioned at American Society for Training & Development meetings 1953 on. Drivers license requirements committees failed to require this training. Are they liable for all of the resulting deaths and injuries?

Safety and error reduction training was a key item when we handed this info to an FBI agent in 1992, and have tried to get them to check references on training errors, omissions, and fantasies in safety,

error reduction, and in ignoring preventive health care and Holistic Health Systems research proving MD RICO many times since. If they had used our geniuses info fully to correct training omissions in FBI, CIA, and DoD, they may have prevented 9-11 and many other disasters. We have mailed media and government elected and hired officials many times, and handed it to several staff and to Rep Davis recently. Since 1992 Military Chief of Staff Colin Powell and State Department ignore Cultural Psychology's research on the Vested Interest Syndrome, safety, and even Cultural Psych research on the effects of language, religion, culture, and sub cultures in Islam and other societies.

I met with SD Police Chief William Lansdowne August 23rd at 5:30. I am sent him a 3rd follow up letter. He gave it to the health expert at the Police Academy, but no indication yet on whether they will check references and act. He did ask some questions. San Diego's Fire Chief discounted our proposal. Can criminal action be taken, or civil suits for damages won, against all who cause these many crimes, and/or those who fail to stop them when advised that they are ongoing? Is the failure to use safety training actionable? Can all elected and hired management be held liable for aiding manslaughter?

Is a class action suit feasible for damaging failures in education, health, and government?
